



# Agenda MiP Meeting

1. Welcome, approval of agenda and minutes of the last meeting – Lead YM / ME

Status of situation at MiPs on activities and geopolitical situation:

- AQUIPLUS: carried out trade show, high activity level
- HUNATIP: growing problems with delivery of feed, increased prices, high inflation, increased production cost
- IATIP: brokerage events for Norwegian suppliers and Irish producers of high interest, mining knowledge for shellfish and seaweed solutions. Difficult funding situation in between EMFF and EMFAF, having as a consequence that IATIP might be governed by IBM
- NCE Aquatech Cluster: Restructuring the platform connected to project work on food safety with network between processing plants, researchers working on how to deal with new regulations on effluents; a network on fish welfare to fight mortalities; conference TEKSET <u>https://tekset.no/</u> on land-based aquaculture with student involvement; focus on circularity; mapping of test facilities in the region to stimulate cross-use of facilities.
- AQUIMER: new government and new elections complicates situation of the cluster, with new financing regime. Dealing with waste of algae, cooperation about circular economy, French event to increase collaboration
- Blue Bioeconomy cluster (prev. BAMS): 46 members incl algae, RAS, primary production. Runs on national funds, activities with model sites for aspects linked to aquaponics, side streams from aquaculture and circularity; war has had impact on national financial situation, providing jobs to refugees, and on energy costs for operation (not possible to have support from EMFAF – as yet)
- Aquaculture Vlaanderen: 8 projects running, escalating prices



These issues of geopolitical impacts on aquaculture will be communicated to the EC and the AAC. Ukraine is an Associated Member State in Horizon Europe. If other information is available, please let us know!

Additional developments:

- At UoS in Scotland, new funding was received and will be rebranched as the national centre for aquaculture research and innovation. EATiP is discussing how we can collaborate.
- Wageningen University has launched a new initiative / network W-ARE, to stimulate crossdisciplinary approach in aquaculture.

# 2. Blue Economy Smart Specialisation / I3 follow-up – Lead DB

EATIP has had meetings with other bioeconomy ETPs on common issues about the need for a clarification of the role of ETPs in Missions, European Partnerships. The collaboration is channelled through the DG RTD Food Systems unit (Karen Fabri), as it is important to know the timetable for ETPs and/or Member States to interact with the Commission.

Meetings with DG MARE and DG RTD were held. In the latter, aquaculture is struggling to get sufficient attention as a member of staff (Miguel Lizaso) left the Healthy Ocean unit.

DG MARE Blue Economy unit is restructuring, with the set-up of a research section taking more responsibility in aquaculture.

DG MARE and DG REGIO are setting up the S3 (Smart Specialisation Strategy) platform on sustainable blue economy, with the plans to support an aquaculture interregional blue economy partnership. The Blue Economy S3 platform will the 4<sup>th</sup> one, complementing the existing ones on energy, agri food and industrial modernisation. There will be a brokerage event to investigate the setting up of an aquaculture pilot project as part of the S3 platform on sustainable blue economy. This event will be held jointly by DG MARE, DG REGIO and EATIP, on June 21 in conjunction with the EATIP AGM. There will be presentations about the instrument from other sectors (agriculture in Tuscany region). A premeeting will be organized. Those that have expressed interest are: ACUIPLUS (ES), the B2E (Blue BioEconomy CoLab in Portugal), and the BlueBioeconomy Cluster (DE). Other MiPs are invited to join. Regional administrative representatives will also attend.

Regions are also working on innovation strategies for ERDF incl blue economy and aquaculture. Until now, this has had no impact on EMFF (only on Structural Funds) as there is no harmonization between the funds.

#### 3. Collaborative actions and Project Activities – lead YM, ME, DB

**Erasmus+ initiative**: a presentation of the outline of the proposal and an update was given by Yolanda and Ana at ACUIPLUS. The call has focus on vocational training. It is the idea to have EATIP leading, with the Clusters and providers of vocational training as partners. Proposal deadline: September 2022.



MiPs were invited to express their interest. Stefan has already done some work on the issue from an Interreg project. There may be an interest from the Swiss RAS cluster. A vocational centre needs to included – either as part of the cluster or as separate partner. The challenges is that there will be a strong competition. Another proposal is being planned by CPMR after a previously unsuccessful proposal. There is a lot of ongoing work, so it is important to look into the project design and build in a legacy – how to establish a Q4 approach for a long-term structuring? It will be important to develop a unique concept including soft skills (digitalisation, entrepreneurship, design, technology) that might match emerging needs and developments. Yolanda / Ana proposed a time schedule, and will share the concept note will all MiPs in order to ask for interest. A new project will be created on BC for those joining the consortium.

It was informed that DG MARE will be putting out a call for Blue Skills, where EATiP also could have a possibility to apply. It was proposed to connect the general work on capacity building to DG MARE. It was advised to look into the list of recommendations from Blue Skills. EATIP submitted several proposals under Cluster 6 and Mission Ocean and was included in a CINEA tender on the Aquaculture Assistance Mechanism.

Clusters were encouraged to announce interest for consortium partners through BC.

No further news to report on the Novel Food issues for aquaculture.

The development of national and international standards is ongoing – see the earlier example of standard process plastic use in aquaculture and fisheries. Standards represent strong incentives for impact of new research. Stefan M is involved in the working group defining the roadmap for the establishment of a new global standard: smart farming/digitalization across agri- and aquaculture. More updates to follow.

## 5. Updated MiP Map / Data – status

Updated logo's and those figures supplied to date have been collected in order to produce a new EATiP MiP infographic. A further follow-up is postponed until the EATiP intern Estelle returns to the office. All MiPs are asked to respond to the requests.

## 6. Request for MiP opinion from EATiP BoD

During the latest EATiP Board Meeting (25 April 2022) the issue of commencing a review of the EATiP SRIA was discussed. A request has been made for the MiP Platforms to provide some initial comments on the current SRIA & Recommendations, specifically with regard to what has changed on the RTDI landscape at a regional/national level (e.g. as included in the multi-annual plans) in the past 5 years that might impact on prioritisation / presentation of RTDI goals. This work will be taking place in the coming weeks.
